



Thorpe III aka Bud Thorpe** on **Monday, January 25, 2010, knocked at 4:00 p.m., then sat in car watching house until 4:15 p.m. (his vehicle was not in the driveway); Tuesday January 26, 2010, knocked at 8:40 a.m. and again at 11:00 a.m. watched house from 8:40 a.m. to 11:15 a.m. (vehicle was in the driveway); called house phone and cell phone 6 times; Thursday January 28, 2010, knocked at 3:05 p.m. and watched the house until 4:00 p.m. (his vehicle was in the driveway); and Monday February 1st, knocked at 3:30 p.m. and watched the house until 3:45 p.m. (his vehicle was in the driveway) and no one answered the door**.
